Section 4: First aid measures

4.1. Description of first aid measures

4.2. Most important symptoms and effects, both acute and delayed

Skin contact: There may be mild irritation at the site of contact.

Personal precautions: Notify the police and fire brigade immediately. Eliminate all sources of ignition. Turn leaking containers leak-side up to prevent the escape of liquid.
